2023 BUDGET PREPARATION AND DUES INCREASE JANUARY 1, 2023

A lot of work goes into preparing the annual budget. It's a complex endeavor that starts in September, to be finalized and approved prior to the beginning of the calendar year. Here's how we do it:

- The Board of Directors and Community Manager work to gather all financial information needed to project expenses for the coming year. This includes an annual reserve analysis of our reserve assets, the cost for future replacements our fencing, trails, landscape, mail boxes, vendor service contracts, projections for utilities comparisons of past years' and future budget trends.
- The Board also examines the sources of income; monthly assessments and interest on our reserve investments.
- As a result of this review, the Board determined that assessments will need to increase \$5.00, being \$97.00 per month for the upcoming calendar year, effective January 1, 2023. We think this to be a reasonable considering our increasing insurance policy due to the fire zone we live in, increase water use for our slopes/landscape due to the drought, the Association vendors increasing their prices, and the necessity to properly fund our reserves during these inflationary times. We mentioned the potential for an increase in last year's budget cover letter and the dues have not increased since 2019. With that said and looking forward to 2024, and if upward pricing pressures continue, we may not be able to keep the dues at their current rate next year.
- The 2023 budget was mailed in November. If you are on ACH the increase will auto-adjust, however, if you have your bank pay, you need to inform them of the new amount to avoid a deficit, and becoming delinquent.
